Field Terminated, with agonal respirations, Medical Control stated to terminate. Medical Examiner arrived 3 hours later, found patient still had agonal respirations as well as palpable pulses. Patient transported; care transferred. No outcome data available. Paramedic was placed on restriction, remediated, back to practice. Second was a BLS call for chest discomfort/rapid A-Fib. BLS 12-Lead performed. Called for ALS, then cancelled ALS. Documentation concerns. Focused re-education for BLS crew.
